Methodology

Probe Research surveyed a representative sample of 1,000 adults residing in Manitoba from July 24 to August 11, 2025.

Those who responded to the online survey are members of Probe Research's proprietary panel, as well as members of another national online panel.

Because an online panel is a non-probability sample, no margin of error can be ascribed. For the purposes of comparison, a probabilistic sample of N=1,000 Manitoba adults would have a margin of error of ± 3.1 percentage points, 19 times out of 20. The margin of error would also be higher within each of the survey's population sub-groups.

Minor statistical weighting by age, region, gender and educational attainment was applied to this sample to ensure it properly reflects the known attributes of the province's population. Probe used SPSS software to conduct the statistical analysis.

The survey questions were designed by Probe Research in close consultation with Association of Manitoba Municipalities/Association of Manitoba Bilingual Municipalities (AMM/AMBM).

Results may not add up to exactly 100% due to rounding. Numbers of <2% are not shown in the graphs.




Support for Federal Funding to Municipalities

Citizens overwhelmingly agree the federal government should provide funding for infrastructure

1. The federal government is encouraging municipal governments to ensure more housing is built in local communities across Canada. Municipalities indicate that to do this, they need more federal funding to help pay for necessary water and wastewater treatment infrastructure – things like water treatment plants, sewer pipes, sewage lagoons, etc.


Those most likely to **agree** include:

- Those who voted NDP in the 2023 election (91% vs. 78% among PC voters).
- Older Manitobans (88% vs. 80% among those aged 18-34).

Views on Federal Housing and Infrastructure Policies

Seven in 10 believe housing/infrastructure policies should be flexible for different-sized communities

2. When it comes to federal housing and infrastructure policies for municipalities, which of the following comes closest to your position? (Base: All respondents, N=1,000)



Those most likely to agree these policies should be flexible to account for the needs of communities of different sizes include:

- Those living in rural and northern Manitoba (74% vs. 68% among those living in Winnipeg).
- Current NDP supporters (75% vs. 65% among PC supporters).
- Women (74% vs. 67% among men).
- Older Manitobans (74% aged 55+ vs. 64% among those aged 18-34).
- University graduates (80% vs. 64% among those with a high school diploma or less).
